



<u>Consultation on the reduction of the Published Admissions Number at</u> Windlesham Village Infant School for September 2021

Windlesham Village Infant School seeks opinions regarding their wish to reduce the Published Admissions Number from 60 to 30, with effect from September 2021.

Before 2013, Windlesham Village Infant School had a Published Admissions Number of 40 and operated mixed-age classes for all year groups, due to fluctuating numbers. This made it very difficult to plan ahead and deploy staff effectively. Our school was expanded to a 2- form entry infant school with a Published Admissions Number of 60 in 2013, in cooperation with Surrey County Council, to meet a growing basic demand for infant school places in the area and to provide stability of numbers.

Since 2016, Surrey has been dealing with a declining birth rate and our numbers have fallen accordingly over time. Fewer children in our school has had an impact on our budget, which has continued to be mitigated by the ongoing flexibility of the school staff and academy reserves. Income generation has been a key focus for the school and lettings have significantly increased over the past year, although much-needed revenue and marketing opportunities have been lost due to school closure over the recent COVID-19 pandemic.

Until recently, the Local Authority had asked our school to maintain its Published Admissions Number of 60, despite falling rolls, so as to meet the demand in school places in the coming years. However, with a continuing trend of lower birth rates in Surrey Heath and limited housing development, it is clear that there is less demand for school places in Surrey Heath and Surrey County Council can now support our application to reduce our annual intake to 30.

The birth rate in Surrey Heath has been in decline since a peak in 2008, which has impacted upon the number of pupils needing a school place for Reception each year for all schools in Surrey Heath.

Given the decline in demand and the choice of good schools in the area, our numbers have been in a state of flux for some time and we have to be reactive to numbers, meaning uncertainty for parents and staff.

The below table shows the predicted number of births in Surrey Heath, based on demographic data from the Office for National Statistics (ONS) and taking into account estimated population projections and migration factors. This illustrates that the birth rate is expected to plateau, with small decreases year on year.

Remaining a two-form entry school with a Published Admissions Number of 60 is no longer sustainable for Windlesham Village Infant School and budget information shows that the school is currently operating an in-year deficit.

Pupil place forecasts

The local authority combines birth data with pupil movement trends and housing data in order to produce a forecast of pupil numbers.

Below are the Reception year pupil forecasts for the planning area of Windlesham, Bagshot and Lightwater, in which our school is located, and for the borough of Surrey Heath as a whole. The data demonstrates there is to be a predicted surplus of places in not only the planning area, but across the entire borough. Please note that, for the purposes of these forecasts, the Published Admissions Number for Windlesham Village Infant School is still assumed to be at 60.

- Clear staff deployment plans

It should be made clear that we have agreed with Surrey County Council that we would revise our Published Admissions Number in the future if there was to be an increase in the demand for Reception places in the borough.
